A. Technical Overview

Sprint 157 (March 25, 2021 – April 7, 2021) has been completed. In this sprint, the team started implementing three new features for the Report Exporter: Survey, Associations, and Roles. Additionally, there was some refactoring of the UI code for better reuse.

Sprint 158 (April 8, 2021 – April 21, 2021) has been completed. In this sprint, the team finished the three new features in the Report Exporter and gathered feedback from the editors on theses features. The LexEVS system tests were updated to use MySQL 5.7 Docker image.

Sprint 159 (April 22, 2021 – May 5, 2021) has been started and will be reported on next month.

We also provided continued product maintenance and deployment support across all sprints.
