#### A. <u>Technical Overview</u>

Sprint 181 (24/Feb/22–10/Mar/22) has been completed. In this sprint, the team removed another generation of log4j vulnerabilities from applications, updated remote and service tests. They also worked with the systems and browsers teams to create AWS proxies and Sumo Logic connectors on Cloud instances. Ongoing updates for other vulnerabilities were completed as well

Sprint 182 (10/Mar/22–23/Mar/22) has been completed. In this sprint, the team supported the load of the latest NCI Metathesaurus, continued work on a CTS2/Uri Resolver issue, provided updated monitoring support for applications, and updated all our NCIP channel github projects to remove obsolete branches and merge into main latest releases. We also pushed forward deployments and releases of a variety of fixes, and one new application.

Sprint 183 (23/Mar/22–07/Apr/22) Will be completed at the end of this reporting period and has been reported on accordingly. We started an upgrade and expansion to the URI Resolver, adding top level domain resolution capability. We completed duration reporting on the Sumo Logic dashboards. The full system test was updated to account for updates to the log4j remediation. We have an ongoing investigation into the NCIm MedDRA representation in LexEVS and the broken hierarchy that's resulted from that.

We also provided continued product maintenance and deployment support across all sprints.
