A. Technical Overview

Sprint 12 (September 3, 2015 – September 16, 2015) consisted of implementing Lucene "matching designation" search functionality on a codedNodeSet. We also worked on updating the LexEVS GUI to allow multiple loads through the same dialog. This feature was implemented on the 6.3 branch and will be merged to the latest branch.

In sprint 13, (September 17, 2015 – September 30, 2015) we completed work on implementing additional search functionality including exact match, contains, phrase, and literal. We started designing union and mapping searches for our new Lucene implementation. We also worked on updating the LexEVS GUI to filter out resolved value set definitions form the coding scheme dropdown. This feature was implemented on the 6.3 branch and will be merged to the latest branch.

Other miscellaneous issues worked on included an OWL2 loader issue, starting to document the new Lucene search algorithms and updating the value set viewer to point to NCI's CTS2 REST URL.

We also provided continued product maintenance and deployment support across all sprints.
