#### A. Technical Overview

We finished sprint 24 (February 18, 2016 – March 02, 2016). In this sprint, the core Lucene development was completed. Several LexEVS GUI issues and admin scripts were also resolved during this sprint. Additionally, LexEVS 6.3.0.2 was tagged and released.

We finished sprint 25 (March 03, 2016 – March 16, 2016). In this sprint, we updated and configured LexEVS Remote API to run locally with LexEVS 6.4 Lucene changes. We also updated the LexEVS admin UI to run with the latest changes of LexEVS and tested the CTS2 URI Resolver with LexEVS 6.4. We also performed search profiling on LexEVS.

We finished sprint 26 (March 17, 2016 – March 30, 2016). In this sprint, we configured and validated LexEVS CTS2 to run against the LexEVS 6.4 Lucene changes. We also deployed the latest LexEVS 6.4 Lucene changes to the Nexus server. Additionally, we fixed serialization issues found in our LexEVS code base that affected the LexEVS Remote API.

Sprint 27 (March 31, 2016 – April 13, 2016) was started this month, but there are no updates for this month.

We also provided continued product maintenance and deployment support across all sprints.
