Project Status Update

- SAE Integration
 - Two open action items to review before finalizing recommendations
- OPEN
 - Start the 1 week final recommendations review on 10/21/15
- CDUS
 - Start CDUS Abbreviated as it is primarily demography
 - 38 Unique CDEs
 - Next step will be CDUS Complete which in addition to the demography data also includes response and toxicity data.
 - Can leverage the toxicity work that the NRDS developed for caAERS.
- Understand there are some overlap in CDEs between SAE Integration, OPEN and CDUS. Working with CTSU to develop a plan to deliver a harmonized set of content.

Content	Data Element	Action Item/NCI Guideline
SAE Integration	Onset Date and Resolution Date	Per NCI Leadership agreed these are important fields to capture for CDUS complete so we can add them to the AE form but keep them conditional
SAE Integration	PVs for Indicator Value Domain	COG's/Theradex has raised a concern This is a change from the original charge from the biostatistician group meeting Need to follow the Policy Group Guiding Principle: Change codes for existing data elements only when a need exists Should we follow CDUS Coding which is all numeric? Take this back to your group for a final vote next week

OPEN Demography

Content	Data Element	Action Item/NCI Guideline
OPEN Demography	Disease Coding	Per NCI Leadership: If there is a national or international standard we should move to that. We recognize that it may take time to implement but we need to be forward thinking in what the rest of the community is doing. Current standard is not a long term solution Per NCI Leadership, leave this CDE as a separate item and move forward with the rest of OPEN.
OPEN Demography	Method of Payment	Checking to see what Congress is currently looking for. Per NCI Leadership, leave this CDE as a separate item and move forward with the rest of OPEN.
OPEN Demography	Method of Payment and Patient Gender	Two fields are retired CDEs, we will be moving to the standard CDEs.
OPEN Demography	SSN#	Discourage the use of making this field mandatory
OPEN Demography	Full Name	Discourage the use of making this field mandatory
OPEN Demography	Patient Initials	Discourage the use of making this field mandatory
OPEN Demography	Patient Hospital #	Discourage the use of making this field mandatory
OPEN Demography	Country Code	Remove "other". Make updates based on the ISO list and forward to CTSU for changes
OPEN Demography	Zip Code	Interest in changing this to mandatory per NCI Leadership but nothing has been changed
