A. Technical Overview

Sprint 109 (May 23, 2019 – June 5, 2019) has been completed. In this sprint, there was work completed to update the sorting mechanism for the asserted valueset hierarchy, LexEVS Remote tests were updated and the LexEVS system tests were temporarily patched in order to keep them from failing. As part of this sprint, we released a snapshot build for LexEVS.

Sprint 110 (June 6, 2019 – June 19, 2019) has been completed. In this sprint, there was a new feature implemented for the TreeService to set the max number of children to retrieve. There were also preparations for assisting the QA team with testing our LexEVS artifacts. As part of this sprint, we released a snapshot build or LexEVS.

Sprint 111 (June 20, 2019 – July 3, 2019) has been started and will be reported on next month.

We also provided continued product maintenance and deployment support across all sprints.
