

# Beta PMI Central Study ALS v1.0 and PROD PMI Central Study ALS v1.0

## Difference Details

The PROD Precision Medicine Initiative (PMI) Central Study Architect Loader Spreadsheet (ALS) v1.0 includes all modifications made to the Beta PMI Central Study ALS v1.0. The modifications details are listed below.

- 1. Beta PMI Central Study patch ALS v1.0.1.0:** Modifications are relevant to the Practice environment. Custom Functions (CFs) were modified to remove '(T)' from the Subject ID in the Payload for Practice mode and include 'practice' in the payload to redirect transactions to the practice environment in MATCHBox for Screening Protocol forms 'PMI CDISC Off Study Standard Form' and 'PMI CDISC Consent Withdrawal Standard Form', and Treatment Protocol Forms 'PMI CDISC Off Treatment Standard Form' and 'PMI CDISC Consent Withdrawal Standard Form'.

The following CFs were modified in the Beta PMI Central Study ALS v1.0.1.0:

- PMI\_UTIL\_InvokeWSViaRaveAPI –
    - Modified CF to remove '(T)' from the Subject ID in the Payload for Practice mode.

    - Modified CF to remove '(T)' from the Subject ID in the Payload for Practice mode.
  - PMI-CONSENT\_doProcessEC –
    - Log updates. No code changes.
  - PMI-OFFTX\_doProcessEC –
    - Log updates. No code changes.
- 2. Beta PMI Central Study patch ALS v1.0.2.0:** Modifications were made to accommodate log fields added by Groups to the PMI standard forms listed below. The following CF was modified in the Beta PMI Central Study ALS v1.0.2.0:

- PMI\_UTIL\_HasAnyQueries – CF modified to ignore log fields added by Groups to the following PMI standard forms:
