Tree Evaluation – Feedback	<ul style="list-style-type: none"> <li>2 use cases for crossing namespaces <ul style="list-style-type: none"> <li>May want to go to different coding system</li> <li>May want to stay in same coding system <ul style="list-style-type: none"> <li>For example, NPO; stay in the same coding system.</li> <li>Reference is a subclass relationship.</li> </ul> </li> </ul> </li> <li>Gilberto feels we can manage through the manifest.</li> <li>Scott suggested that changes could be made to the loader - in addition to using the manifest.</li> <li>Agreed, this can be managed through the manifest</li> <li>NCI will confirm that the manifest and tree jar that Scott put on sftp will work.</li> </ul>
CTS2 API documentation	<ul style="list-style-type: none"> <li>TLAMP documentation based on tool IO Docs <ul style="list-style-type: none"> <li>Needs to run on NodeJS (requires a JS server to run)</li> <li>NodeJS cannot run at NCI (not secure) - reasons unknown?</li> <li>Is it possible to use Apache as a proxy for NodeJS? Cory will verify if this is possible.</li> <li>NodeJS wasn't used for URI Resolver (it was rewritten).</li> <li>Gilberto to follow up with NCI security team.</li> <li>Cory to look at additional ways to accomplish this.</li> </ul> </li> </ul>
