- **Note to NCTN Statistical Center Pls:** Please be sure to discuss within your Stats Center the code changes being proposed to ensure the benefits outweigh any potential challenges. One change in particular to review is changing all numeric responses of '1' or '2' to a character

response of 'Y' or 'N' (for Yes and No). There are 30 coded indicator value sets impacted by this 1,2 to Y,N coding. All of these changes can be found on both the caAERS AE and SAE CRF before/after spreadsheets.
