It would be additional work for the DEV team. Lucene doesn't advise this.</div> <div>This should be working with the new Lucene work. We will need to test.</div> <div>These special properties could have their own analyzers for searching.</div>

We would match up the query with specific analyzers.</div> <div>We should consider the potential of SQL injections for this implementation.</div>
<div>HTTPS - Applications Migrating to HTTPS</div> <div><div><div>LexEVS CTS2 REST Services - via Apache</div><div>LexEVS API Services</div></div></div>	<div>The REST service should be fine. We will just need to redirect in the Apache configuration.</div> <div>LexEVS service would need to be updated for HTTPS.</div> <div>TODO: Create JIRA items and put them in the backlog for after 6.4.</div>
