



Value set resolution issues at NCI <ul> <li>Updates</li> </ul>	Kim has created JIRA issues for some concerns he has (LEXEVS-1729, LEXEVS-1730, LEXEVS-1731, LEXEVS-1732).

	LEXEVS-1730 - Coding Scheme properties could indicate what version the coding scheme was resolved against. This would happen during the load.
