

SSL and LexEVS 6.4	<p>Discussion Points:</p> <ul style="list-style-type: none"> <li>• 6.3 will continue to run in parallel with 6.4.1.</li> <li>• 6.4.1 - Runs only on security level TLS v1.0. Any higher levels of TLS will cause LexEVS Remote API to fail.</li> <li>• HTTP requests will be forwarded to HTTPS - This is only for testing on DEV/QA.</li> <li>• Here are the specific rules for STAGE/PROD: <ul style="list-style-type: none"> <li>◦ Apache is being used as a proxy, it will handle https for tomcat/lexevs. Both http &amp; https are enabled now in the lower tiers for testing. In production, a client must connect using https, and if it attempts to use http it can be redirected to https; however, the client must be able to switch over to https on redirection.</li> </ul> </li> </ul> <p>Decision Points:</p> <ul style="list-style-type: none"> <li>• HTTP requests will not be forwarded to HTTPS. This will be shut off. <ul style="list-style-type: none"> <li>◦ Gilberto said this is how it will work at the end of year.</li> <li>◦ Only HTTPS will be supported.</li> </ul> </li> <li>• Scott will email and confirm with Jacob that he is shutting off HTTP on QA.</li> </ul>
